INFORMATION AND INSTRUCTIONS FOR THE TOURNAMENT ARE AS FOLLOWS:

The following 2008-2009 National Federation of State High School Associations (NFHS) rules will be used with format modifications:

- All games will be rally scored to 25 points, cap of 27 points, with the exception of the deciding game. If a deciding, or third, game is necessary, it will be rally scored to 15 points with teams switching sides at 8 points. The winner of a game must have a two-point advantage; there is no point cap.
- Libero – will be allowed under the National Federation of State High School Associations (NFHS) rules.

FORMAT:

Pool Play:

- Match - each match will consist of two games, rally scored, of 25 points, cap of 27 points.
- Each team will be allowed one 60-second timeout per game.

Tie-Breaker:

- head-to-head match
- total pool points
- coin toss

Championship Round:

The teams will be re-seeded based on won-loss record following the conclusion of pool play.

The championship round will be double elimination with the exception of the SILVER/BRONZE division which will be single elimination. Each match will be the best of three games to 25 points, cap of 27 points. If a deciding game is necessary, it will be played to 15 points with teams switching sides at 8 points; deuce with no point cap.

The first match will start promptly at 5:00 PM.

Saturday, August 23, 2008

The first match will start promptly at 9:00 AM.

Sunday, August 24, 2008 (Playoffs & Championships)

The first match will start promptly at 8:00 AM.

WARM-UPS:

- There will be 6 minutes between each match. Each team will have 3 minutes use of the entire court.
- NO SHARED HITTING IS ALLOWED.
- NO DIGGING ON THE OPPOSITE SIDE IS ALLOWED.
- The time between games is three minutes.

OFFICIALS

The OIVOA will provide top officials. (If there are not enough officials available, the teams will provide). The teams are required to provide an umpire, scorekeeper, a score board operator, and two line judges.
